Dear Mr. Eakin:

Enclosed please find a sample Vaughn Index. In accordance with the Court's order and due to the selection of documents made in your letter of October 26, 2017, the government is producing a sample index for the first approximately 160 documents removed from the set of documents reviewed for purposes of your FOIA request. Additionally, the government is providing a description of a removal done for purposes of protecting personal medical information. That document is listed last in the sample index and is out of order with the other documents listed. In making this production, the government believes it has now fully complied with the Court's order with respect to the sample Vaughn Index. Please let us know if there is disagreement with respect to our position on that point.

Also in accordance with the Court's order in this case, the government produced 648 gigabytes of IDPFs on October 17, 2017 and 90 gigabytes of IDPFs on December 1, 2017. In making those productions, it is the government's position that we have complied with the Court's requirement to produce previously withheld non-exempt documents and made our first semi-annual production of documents. We will continue to make the semi-annual productions as required.

**Settlement**


As stated in prior correspondence, we have sought a mutually acceptable resolution of this matter. Last week, in an attempt to reach an amicable resolution of this matter, the government produced a set of X-files that the Department of Defense (DoD) was able to release without further review of the material.

The DoD is open to prioritizing certain files which you have indicated are the most important to your research (approximately 3,000 files) and to agreeing to an order that would permit you to request up to 20 files a month until 2020, but only if undertaking those actions would be a mutually acceptable resolution of this case and permit DoD to end its work on the FOIA request at issue in this litigation. If those actions will not resolve the case, we will continue to make the semi-annual productions as required by the Court's order.

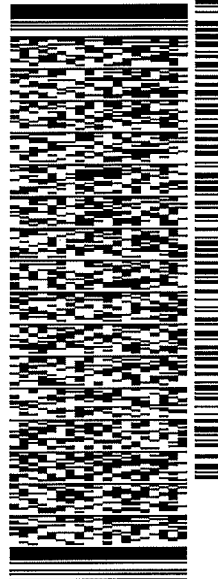

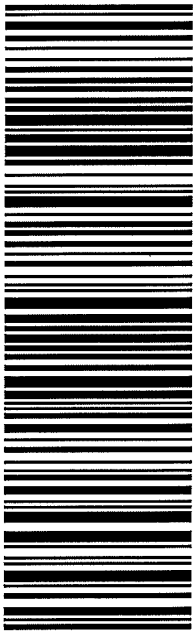
