Mr. Talley,

When I last spoke with DPAA about this issue on March 9, they informed me that digitization was still on track to be completed by the end of April. I have asked for an update on the status of that effort in response to your email below, and will relay that information to you as soon as I have it. I will also let Mr. Eakin know once digitization is complete so that he can quickly make another FOIA request. I anticipate the government, in order to preserve the arguments raised in ECF No. 61, will oppose another motion for leave to amend the complaint. But I recognize the Court did not find those arguments persuasive, and I do not intend to fully brief them a second time. With that caveat, I agree it makes sense for the Court to refrain from ruling on any pending motions until all the M-Z files can be addressed.

With respect to the discrepancies alleged by Mr. Eakin, the government has committed to re-review and re-produce the "F," "G," "I," and "J" IDPFs. The government intends to re-produce the "I" IDPFs this week. I have been informed by AHRC that they are currently processing the "J" IDPFs, and have reviewed (or re-reviewed) approximately 75% of those files. I hope that we will be able to provide them to Mr. Eakin within the next few weeks. AHRC will then process the "F" and "G" IDPFs and produce them to Mr. Eakin as quickly as possible. I intend to file an advisory outlining the government's position on the alleged discrepancies as well as status reports notifying the Court once each set of files are re-produced. I agree with Mr. Eakin that a motion to compel will not be necessary.
