STATUS REPORT

The United States Department of Defense, by and through its undersigned counsel, respectfully files the following Status Report regarding this matter.

1. On March 24, 2021, the government produced 1,591 “I” IDPFs (totaling 19.56 GB) to Plaintiff. This replacement production contained all currently available “I” IDPFs scanned by DPAA contractors, including some or all of those previously produced to Plaintiff.
2. On April 5, 2021, the government produced 9,617 “J” IDPFs (totaling 117.73 GB) to Plaintiff. This replacement production contained all currently available “J” IDPFs scanned by DPAA contractors, including some or all of those previously produced to Plaintiff.
3. On April 29, 2021, the government produced 13,566 “F” IDPFs (totaling 172 GB) to Plaintiff. This replacement production contained all currently available “F” IDPFs scanned by DPAA contractors, including some or all of those previously produced to Plaintiff.
4. On June 11, 2021, the government produced 18,630 “G” IDPFs (totaling 219 GB) to Plaintiff. This replacement production contained all currently available “G” IDPFs scanned by DPAA contractors, including some or all of those previously produced to Plaintiff.
5. Plaintiff recently requested that the government also make replacement productions for all “E,” “H,” and “L” IDPFs. The parties have not yet reached agreement on whether, when, or to what extent those files will be re-produced.
