STATUS REPORT

The United States Department of Defense (DoD), by and through its undersigned counsel, respectfully files the following Status Report pursuant to the Court's July 8, 2022 Order.

- 1. On August 3, 2022, the government produced 17,226 IDPFs to Plaintiff. The volume of this production was 424.1 GB. Included in the production were 12,068 "T" files, 864 "U" files, 8 "X" files, 2,067 "Y" files, and 2,219 "Z" files.
- 2. On September 1, 2022, the government produced 17,966 IDFPs to Plaintiff. The volume of this production was 590 GB. Included in the production were 6,824 "N" files, 5,617 "O" files, 686 "Q" files, 32 "T" files, 4,805 "V" files, and 2 replacement files for corrupted IDPFs from the August production.
- 3. On October 4, 2022, the government produced 13,502 IDPFs to Plaintiff. The volume of this production was 514.7 GB. Included in the production were 13,502 "P" files.
- 4. On November 4, 2022, the government produced 13,122 IDPFs to Plaintiff. The volume of this production was 516.88 GB. Included in the production were 4,988 "P" files, 8,003 "R" files, and 131 replacement files for corrupted IDPFs from the September production.

- 5. On December 1, 2022, the government produced 13,174 IDPFs to Plaintiff. The volume of this production was 476.7 GB. Included in the production were 2 "P" files, 10,716 "R" files, and 2,456 "W" files.
- 6. On January 3, 2023, the government produced 13,000 IDPFs files to Plaintiff. The volume of this production was 311.3 GB. Included in the production were 13,000 "W" files.
- 7. On February 3, 2023, the government produced 13,067 IDPFs to Plaintiff. The volume of this production was 311.28 GB. Included in the production were 7,396 "S" files and 5,671 "W" files.
- 8. On March 7, 2023, the government produced 13,013 IDPFs to Plaintiff. The volume of this production was 310 GB. Included in the production were 13,013 "S" files.
- 9. On April 3, 2023, the government produced 13,004 IDPFs to Plaintiff. The volume of this production was 320 GB. Included in the production were 13,004 "S" files.
- 10. On May 3, 2023, the government produced 13,032 IDPFs to Plaintiff. The volume of this production was 395 GB. Included in the production were 9,299 "M" files and 3,733 "S" files.
- 11. On June 1, 2023, the government produced 13,691 IDPFs to Plaintiff. The volume of this production was 442.7 GB. Included in the production were 13,691 "M" files.
- 12. On July 6, 2023, the government produced 10,346 IDPFs to Plaintiff. The volume of this production was 419.44 GB. Included in the production were 9,782 "M" files, 1 "P" file, 182 "R" files, 181 "S" files, and 200 "W" files.
- 13. In total, DoD has produced 164,010 original files and 133 replacement files over the past twelve months. The total volume of these productions exceeds 5 TB.

- 14. Army Human Resources Command determined that 252 documents received from the Defense POW/MIA Accounting Agency were non-responsive. Those non-responsive files have not been produced.
- 15. DoD reports that there are no more M–Z IDPFs remaining to be reviewed for production to Plaintiff. The production of M–Z IDPFs is complete and in compliance with the deadline set forth in the Court's July 8, 2022 Order.
