

2. It is requested that the previously submitted individual identification recommendation of X-1801 as T/4 Moyd O. Cole be withdrawn inasmuch as the recheck of all of the unknown remains recovered from Grave 212, Cabanatuan PCW Camp Cemetery, has revealed that the remains of X-1801-A compared more favorably for individual identification as Pfc. Gerald W. Sparks. T/4 Cole's Form 371 dental chart contains no distinctive identification factors, wheras Pfc. Sparks' Form 371 did have two specific identification factors in "-13 and R-15 which are in exact agreement with the dental chart for X-1801-A. T/4 Cole is now included among the six unknowns in the group identification.

An examination should be made and findings charted to cover the following basic conditions: lost teeth, crowned teeth, bridgework, fillings, caries (cavities of decay), dentures (plates), and any deformity of jaws found.


